SRO ⁴⁵⁹ In exercise of the powers conferred by proviso to Section 124 of the Constitution of Jammu and Kashmir, the Governor is pleased to direct that in the State Insurance Fund Rules, Rule 7 and the schedule there under shall be substituted by the following :-

"7. The amount of Insurance of an employee's life shall depend on his /her salary drawn on the date he/she makes an application as per the Schedule shown below:-


SCHEDULE

Class in which employees monthly pay (excluding Grade Pay) falls	Sum assured under Scheme "B"
a) Pay up to Rs 5200/-	Rs 25000/=
b) Pay from Rs 5201/= to Rs 9300 /=-	Rs 50000/=
c) Pay from Rs 9301/= to Rs 15600/=	Rs 1,00,000/=
d) Pay from Rs 15601 and above	Rs 1,50,000/=

(i) Provided that an employee falling in any category (a to d) above may however draw out insurance policy for any amount higher than the amount which he has to take compulsorily subject to a maximum limit of Rs 2.00 lacs.

(ii) State Insurance Fund Schedule of premium rates scheme "B" (endowment Assurance) and Surrender value in the State Insurance Rules and Tables of Rates will be as contained in annexure 'C' and 'D' respectively annexed hereto."


