## Circular

Subject: - Implementation of Mediclaim Insurance Policy for all State Government (Gazetted) Employees from 31-03-2014

Ref: -Government Order No.96-FD of 2014 Dated 31-03-2014

In continuation to this department's circular Nos. FD/Mediclaim/08/MR-III dated 09-07-2013, 16-07-2013 and 21-01-2014 where under all the Administrative Secretaries and DDOs were requested to convey the name of the Gazetted Employee along with full particulars and those of his or her dependant family members on the prescribed format to the ICICI Lombard General Insurance Company Ltd.at the earliest. However despite repeated requests various departments have failed to furnish the requisite information to the concerned company till date with the result the Company is not in a position to issue the Health Insurance Cards in favour of the concerned officers/beneficiaries to enable them to get the cashless treatment under the policy/scheme in the network hospitals.

All the Administrative Secretaries/Drawing and Disbursing Officers are therefore, once again requested to convey the name of each such Gazetted Employee along-with full particulars with his or her dependant family members who has not filled and forwarded the same till date on prescribed form to ICICI Lombard General Insurance Company Ltd on the following address to enable them to issue the Health Insurance Cards in their favour for availing cashless treatment in network hospitals. The Finance Department shall not be responsible in case the concerned beneficiaries will face any difficulty/inconvenience in absence of the Health Insurance Cards while taking the benefit under the policy:-
