Whereas, the Jammu and Kashmir Services Selection Board vide communication No.SSB/Sel/Secy/015/2344-50 dated 18-02-2015 forwarded selection list of 25 candidates for the posts of Sub-Inspector(Divisional Cadre Jammu) advertised vide Advertisement Notice No.06 of 2013 dated 10-5-2013; and

Whereas, the formal appointment orders were issued by the Finance Department vide Government Order No. 67-F of 2015 dated 07-05-2015 in respect of the selected candidates with the directions to report to Excise/Commercial Taxes Departments as the case may be; and

Whereas, the appointees were required to report in the respective Department(s) within a period of 21 days from the date of issue of the order failing which their appointment was deemed to have been cancelled without any further notice; and

Whereas, vide abovesaid Government Order No. 67-F of 2015 dated 07-05-2015, Mr. Harvinder Singh S/o S. Mohinder Singh R/o Akhnoor, Jammu, among others, was also appointed as Sub-Inspector(Divisional Cadre Jammu) in the J&K Excise & Commercial Taxes (Subordinate) Service in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 2400/- with the directions to report to Excise Commissioner, J&K for further duties; and

Whereas, Mr. Harvinder Singh S/o S. Mohinder Singh R/o H.No.400 Lane No.10, Hazuri Bagh Bohri, Talab Tillo, Jammu-180002 submitted a representation dated 22-5-2015 wherein he has intimated

that his father is not well for past some time and he was diagnosed with prostate cancer for which he also underwent operation from Rajiv Gandhi Cancer institute Delhi and is also diagnosed with Hepatitis B. On the advice of doctor, the patient is being carried to PGI for further procedures. As such, the appointee has requested to grant him more time to report/join for the duties.

Whereas; the matter has been examined and it has been found that the issue being appointment in Government Service, warrants reasonable opportunity to be given to the said candidates.

Now therefore, Mr. Harvinder Singh S/o S. Mohinder Singh R/o Akhnoor, Jammu A/P H.No.400 Lane No.10, Hazuri Bagh Bohri, Talab Tillo, Jammu-180002, who has not reported for joining in the Excise Department in pursuance of Government Order No. 67-F of 2015 dated 07-05-2015, is hereby once again directed to report in Excise Department alongwith documentary evidence for undergoing medical treatment of his father, within a period of 10 days from the date of issuance of this notice, failing which his appointment as Sub-Inspector (Divisional Cadre Jammu) of the J&K Excise & Commercial Taxes (Subordinate) Service in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 2400/- shall be deemed to have been cancelled ab-initio and operation of the waiting list shall be considered without any further notice/opportunity.
