## CIRCULAR

Subject:- Posting of details of Tender /Contract on official websites.

In order to augment transparency in public procurement, it has been decided, that all Government Departments/PSUs shall upload on their official website, summary of all Contracts/Purchases made during particular month above threshold value of ₹ One Lakh on a devised format forming annexure. The website should also reflect date of Start of work, expected/actual date of completion and reason for delays, if any.

- 2) The Performa should be updated on website regularly till completion of work/supply.
- 3) Accordingly, the Administrative Secretaries of all the departments, and the Managing Directors of all State PSUs are requested to pass on the above decision to their subordinates and ensure its implementation in letter and spirit.
