Subject:- Aadhar Based Biometric Identification and Skill Profiling of Casual/Seasonal Labourers/Workers (CSLWs).

CIRCULAR No: 04-F of 2017 DATED: 24.07. 2017

Vide Circular No. 02-F of 2017 dated 15.06.2017 the last date for up-loading the information online of Casual/Seasonal Labourers/Workers (CSLWs), was extended to 15th of July, 2017 and for submission of certified hard copies on the devised format to Finance Department to 31st of July, 2017. It was made clear to all the Departments that it will be the exclusive responsibility of the concerned Administrative Secretaries to register all eligible CSLWs by or before the said date upon which it will be presumed that the Departments have registered all the eligible CSLWs and no further extension will be granted.

However, upon requests of various departments, the matter has been reviewed and it has been decided to extend the last date for uploading the information online upto 5th of August, 2017 and for submission of certified hard copies on the devised format to Finance Department upto 15th of August, 2017.

The Departments as have not so far completed the process are requested to complete the process of identification of CSLWs by the stipulated dates, beyond which no request for registration will be entertained.
