## Circular

Subject: Non submission of the Enrolment Forms of the Gazetted Officers regarding Mediclaim Insurance Policy where premium stands deducted from their salaries by some DDOs (concerned) to ICICI Lombard GIC Ltd. as on date.

Despite of repeated requests/instructions to all the Administrative Secretaries and Drawing and Disbursing Officers (DDOs) of every department to submit the prescribed enrolment form duly filled by the concerned Gazetted Officer where the premium stands deducted by the concerned DDO to ICICI Lombard GIC Ltd. Jammu/Srinagar against proper receipt to enable them to furnish Health Insurance Cards and provide cashless treatment to the enrolled beneficiaries during the policy period, however, various DDOs failed to adhere the instructions of the Government in letter and spirit with the result some officers could not avail the benefits under the instant policy being the fault of the DDOs. The matter has been viewed seriously by the Government and disciplinary action shall be initiated against the defaulting DDOs who have failed to adhere the directions/instructions in submission of the enrolment forms to the concerned Insurance Company.

Accordingly, all the DDOs are once again directed to submit the left out enrolment forms duly filed by the concerned Gazetted Officers as per the directions of the Finance Department whose premium stands already deducted from their salaries in the prescribed month to the ICICI Lombard GIC Ltd. upto 25th March 2017 positively. The Finance Department does not owe any responsibility in case the DDO shall fail to adhere the instructions. The enrolment forms shall be sent to the concerned Insurance Company on the below mentioned address against proper receipt.

The left out enrolment forms shall be treated as fresh one in the 2nd stage of 3rd year policy upto 24th August 2017 only.
