**Subject: Closure of claim intimation acceptance in respect of Group
Mediclaim Insurance Policy.**

Circular

The Group Mediclaim Insurance Policy for the employees of the State Government was implemented by the Finance Department vide Govt Order No: 406-FD of 2018 dated 22-09-2018 for a period of one year started w.e.f 1st October 2018 and accordingly, after due codal procedure, the Policy was tied up with Ms Reliance General Insurance Company Ltd. The Policy was terminated vide Govt Order No: 555-FD of 2018 dated 28-12-2018 and all the beneficiaries covered under the said policy were allowed to avail the benefits for a period of 3 months w.e.f 1st October 2018 to midnight 31st December 2018, as the Government has already paid the premium on behalf of all enrolled employees for 3 months only.

As per the clause 29 - "**Run Off Period**" of the agreement executed on 15-10-2018, "all expenses incurred in respect of hospitalization that took place till date of cancellation/expiry of the policy is payable and post hospitalization period of 60 days in such cases shall be reckoned from the respective date of discharge from the hospital."

Due to mid term cancellation/expiry of the policy, the run off period for the said policy stands expired on 1st March 2019 and a further extension of 30 days for submission of the claim documents, claim intimations was accepted till 31st March 2019 by the appointed TPAs.

Accordingly, it is for the general information of all the concerned that the run - off period for the policy has expired on 31st March 2019 and no further claim intimation shall be entertained,

henceforth and any intimation received beyond this date shall render the claim invalid and shall be considered as "No claim."
