DigiLocker is an online facility, where the citizens can get authentic documents/certificates in digital format from the original issuers of these certificates anytime, anywhere without physical interface with them.

All Direct Benefit Transfer (DBT) implementing Departments are, therefore, advised to follow the process flow given below for DigiLocker integration and to adopt DigiLocker platform in a time bound manner:

- a. Registration: Authorized officials have to visit the partner portal of DigiLocker (URL: https://partners.digilocker.gov.in) and register as an issuer, requestor, or verifier.
- b. Technical Resources for the integration: Application Programming Interface (API) specification documents are enclosed as an annexure for reference. The same shall be found at the below link: https://digilocker.gov.in/resource-centre.html
