Authorization of 100% Revenue Budget out of Revised Subject: Estimates 2022-23.

In continuation to the Government Order No. 98-F of 2022, dated 31.03.2022 and subsequent authorization of funds from time to time, Finance Department conveys authorization to the release of further funds through BEAMS under Revenue Component for the financial year 2022-23 to the extent of 100% of RE 2022-23 under all the Detailed Heads except in respect of following which shall be released on case to case basis:

- 001-Salary
- 028-Grant-in-Aid
- 046-Purchase of Vehicle,
- 054-Furniture and Furnishings,
- 201-Interest,
- 216-Purchase of Power,
- 311-Cost Price of food grains,
- 411-Refunds,
- 633-Compensation,
- · 799-Suspense Debit; and
- 1076-Disaster Response Fund.

However, the utilization of funds so authorized shall be subject to the following conditions:

- 1. The Departments shall review the expenditure under revenue budget and shall ensure the strict avoidance of unnecessary and unfruitful expenditure by the DDOs subordinate to them.
- 2. The Controlling Officers under the Department shall exercise extra caution and shall ensure that further funds are released as per the actual requirement of the DDOs.

3. The utilization of funds shall be subject to the other detailed conditions as stipulated vide Government Order No.98-F of 2022 dated 31.03.2022.
