**Subject:-** Tentative Seniority list of Drivers of UT/ Divisional Cadre (Jammu/ Kashmir ) of J&K Excise and State Taxes Department (Subordinate ) Service as on 01.09.2023.

**NOTIFICATION**

Whereas, vide Government Order No. 334-FD of 2017 dated 08.11.2017, the seniority list of Drivers of Excise and State Taxes Department (Subordinate) Service as it stood on 01.01.2017 was notified by the Finance Department ; and

Whereas, the Commissioner State Taxes Department vide letter No. 178-II/Adm/7240/CST dated 20.01.2023 forwarded the details and service particulars of the Drivers for updation of their seniority list and the matter was examined and it was observed that the seniority list of Drivers of J&K Excise and State Taxes Department (Subordinate ) Service is required to be updated on account of fresh appointment(s), promotion(s), retirement(s)/death(s) of the concerned officials, as a result of which names of all such officials need to be included/excluded from the respective categories of the seniority list; and

Whereas, the Commissioner, State Taxes Department vide letter No 178-Adm/1700/CST dated 04.10.2023 and Excise Commissioner, J&K vide letter No. EC/ Adm (seniority-Driver) /E-7129467/4804 dated 26.09.2023 have furnished the latest list of Drivers of J&K Excise and State Taxes Department (Subordinate ) Service of UT Cadre and Divisional Cadres Jammu/ Kashmir, as stood on 01.09.2023; and

Whereas, the information submitted by Commissioner, State Taxes Department and Excise Commissioner, J&K has been examined and a tentative seniority list of Drivers belonging to J&K Excise and State Taxes Department (Subordinate ) Services as it stood on 01.09.2023 has been prepared;

**Now therefore**, through the medium of this notification and enclosed Annexures-A, B & C a tentative seniority of Drivers belonging to J&K Excise and State Taxes Department (Subordinate) Service as it stood on 01.09.2023, is issued for inviting objections, if any, from the concerned quarters, which shall be submitted within a period of 21 days



from issuance of this notification. The tentative seniority list is issued with the following conditions:-

1. The members of the service are directed to file their objections, if any, in the Administrative Department (Finance) Civil Secretariat, J&K within a period of 21 days from the date of issuance of this notification with documentary proof in support of their claims, after which no objection(s) shall be entertained and Final Seniority list shall be issued accordingly.
2. The Date of Birth reflected in the seniority list shall be subject to its authentication and verification from the Service Book/Date of Birth Certificate of the concerned employee, as envisaged under rules. Officials whose Date of Birth is not mentioned in the tentative seniority list are directed to submit their bio-data alongwith the Date of Birth Certificates and first page of Service Book duly authenticated by the concerned Drawing & Disbursing Officers through concerned HOD.
3. The reserved Category status reflected against the officials in the tentative seniority list shall be subject to its authentication and verification from the competent issuing authority.
4. In case the Reserve Category Certificate(s) furnished by any official is found to be false /fake later on, the same shall be deemed to have been cancelled ab-initio and all the benefits which the officials (s) would have availed on the basis of such false/fake certificates shall stand withdrawn from the date of receipt of such benefits by him/her. Besides, appropriate disciplinary action under rules shall also be taken against him/her.
