Finance Department vide No. A/106(03)-II-244 dated 11.01.2020 read with FD-code/140/2022-02-1899 dated 24-02-2023, had issued following circular instructions regarding procurement of Goods and Services by Government Departments /PSU's produced and provided by Micro and Small Enterprises ;

- In a tender participating MSMEs quoting price within price band of L1 + 15% shall also be allowed to supply a portion of requirement by bringing their price to L1 price. In a situation where L1 price is from someone other than MSMEs, such MSME shall be allowed to supply upto 25% of total tendered value.
- Every Department or PSU shall procure a minimum of 25% of total overall annual procurement of goods and services from the MSMEs.
- 3. Out of the total annual procurement from Micro and Small Enterprises, 3 per cent from within the 25 per cent target shall be earmarked for procurement from Micro and Small Enterprises owned by women.

In order to avail price preference, functionalities have been deployed in GeM. A clause has been provided in ATC Library for effective implementation of all the provisions of MSMEs order.

All the sellers claiming to be MSMEs are required to validate their MSMEs status through Udyog Aadhar.

Regarding 358 items which have been reserved exclusively for purchases from MSMEs, the tender/bids are required to be invited from MSMEs only on the GEM portal.

Accordingly, all Administrative Departments are requested to circulate these instructions to all HODs, DDOs, Corporations, Boards, Local Bodies, PRIs and Agencies under them and ensure strict compliance.

The Industries & Commerce Department should advise and facilitate the MSMEs from Jammu and Kashmir to register themselves on GEM portal.
