Subject:- Clarification of doubts expressed on account of implementation of J&K Civil Services Revised Pay Rules, 2018.

Consequent to the notification of J&K Civil Services Revised Pay Rules 2018, some doubts have been expressed and clarification whereof has been felt necessary.

2. These doubts are clarified as under:-

S.No	Doubts	Clarification
1	Applicability of revision of Pay in respect of employees covered under J&K Special Recruitment Rules, 2015 notified vide SRO 202 dated 30.6.2015.	The employees appointed under the J&K Special Recruitment Rules, 2015 as notified vide SRO 202 dated 30.6.2015 shall also now get basic revised pay as per J&K Civil Services Revised Pay Rules, 2018.
2	Whether payment of allowances linked to basic pay such as Hardship Allowance, Risk Allowance, Conveyance Allowance, Non-Practising Allowance, Travelling Allowance, Charge Allowance, are to be paid on revised pay.	No allowances other than Dearness Allowance and House Rent Allowance have been revised. As such, all the allowances other than DA & HRA shall continue to be paid as per pre-revised rates at pre-revised pay in pre-revised Pay Bands/Pay Scales till further orders after review of these issues by Finance Department on case to case basis.
3	Crediting of NPS amounts out of arrears of Pay on account of revision of Pay w.e.f 1.1.2016 to	The due amount of NPS arrears both employees' share alongwith employers' share out

31.3.2018 in respect of employees covered under NPS in addition to crediting of arrears to GPF accounts.	of the arrears of salary/pay for the period 1.1.2016 to 31.3.2018 shall be remitted towards NPS in usual manner, and rest of the arrears amount of salary/pay shall be credited towards GP Fund accounts.
