

Two cases of DRWs of Animal Department were examined in terms of provisions contained in the J&K DRW/WCEs (Regulation) Rules, 1994 notified vide SRO 64/1994 read with Government order No. 26-F of 1994 dated 31.01.1994 and the Committee found these cases incomplete and deficiencies as observed are shown against each:-




S. No.	Name/Parentage/ Address of DRW	Observations/Deficiencies
1.	Rehana Naqash D/o Fareed Ahmad Naqash R/o Ahmed Nagar, Srinagar.	The department shall issue and furnish a speaking order under seal and signatures of HoD, inter-alia, certifying therein :- i. The incumbent has been engaged as DRW w.e.f 01.01.1994. ii. The incumbent has actually rendered services to the department from 01/94 to 10/94. iii. The incumbent has continuously worked from date of initial engagement till date. iv. The incumbent is eligible for regularization in terms of SRO 64/1994.
2.	Gull Mohd. Sheikh S/o Daiem Sheikh R/o Janglatmandi, Anantnag.	The department shall:- i. Clarify and justify as to how wages have been paid on consolidated basis against daily wage rates from 05/91 to 02/05. * ii. Furnish continuity certificate from date of initial engagement till date duly countersigned by concerned HoD. iii. Furnish upto date service sheets duly countersigned by concerned HoD.






