Proposals of Industries & Commerce Department and Food, Civil Supplies & Consumer Affairs Department relating to regularization of Sh. Mushtaq Ahmad Wagay and Sh. Mohd. Yousuf Shah, DRWs, respectively against available Class-IV posts in addition to 383 fresh cases and 31 review cases of left out DRWs of various departments were on agenda of the meeting.


Sh. Mushtaq Ahmad Wagay S/o Mohd. Abdullah R/o Lessu Kokernag, District Anantnag was initially engaged as DRW by the department on 21.07.1993. The department has not registered him as left out DRW with Finance Department. However, the department had recommended regularization of the DRW against available post of Store Khalisi (Class-IV) (state cadre post).

The case was examined in terms of provisions contained in the J&K DRW/WCEs (Regularization) Rules, 1994 notified vide SRO 64/1994 read with Government order No. 26-F of 1994 dated 31.01.1994. The Committee recommended that the department shall consider regularization of the incumbent in the pre-revised pay scale of 2550-3200



w.e.f 01.04.2001 against the post of Store Khalisi (Class-IV) (state cadre post) available with the department subject to following conditions:-


- (i) The Department shall verify records to establish genuineness of the claim.
- (ii) The department shall obtain condonation of breaks from 26.08.1995 to 02.09.1995 from the Competent Authority.
- (iii) Continuous working from the date of initial engagement and drawal of wages at notified rates shall be established/certified by the concerned HoD.
- (iv) The incumbent is eligible for regularization and fulfills all conditions as laid down in SRO 64/1994.
- (v) Relaxation of age/qualification, if any, shall be considered by the Department with prior approval of the Competent Authority.
- (vi) Arears from date of regularization to the date of issue of regularization order shall be paid in five equal annual instalments after projecting the same under Annual Budget Estimates of the Department.






