

Cases of 235 DRWs of PHE Division Shopian were examined. While examining the case files of these incumbents in terms of provisions contained in the J&K DRW/WCEs (Regulation) Rules, 1994 notified vide SRO 64/1994 read with Government order No. 26-F of 1994 dated 31.01.1994, the Committee cleared and approved creation of 218 posts of "Helper" in the pay scale of 2550-3200 (Pre-revised) for regularization of as much number of DRWs from the dates shown against each in the below matrix. In respect of S. No. 1 to 149, seven years continuous service has been computed from 01/94 i.e culmination of last break prior to 01/94:-
