Two hundred and ninety nine (299) cases of different Departments were listed and placed before EC for consideration. The breakup of these cases is given as under:

During the scrutiny of cases, EC found that 202 cases of the listed 299 have not completed 7 years of service. 50 cases were found deficient as these cases were not supported with the requisite documents which are required under the Act. Only 47 cases were found eligible. Departmentwise breakup is given in Annexure "A" to these minutes. It was also pointed out that the concerned departments have not furnished complete information/ documents in a number of cases. Further some of the cases of Jr. Engineers of Rural Dev. Departments were found to have borne on the establishment of Public Works Department, thus the concerned department was advised to furnish a clarification in this behalf. It was also decided that the cases where appointees have not completed 7 years of service shall be returned to the concerned department with the advice that they shall resubmit their cases complete in all respects as and when they complete 7 years of service. In respect of three deficient cases, the representative of the department was advised to expedite the relevant deficient information so that further action on the issue could be taken by the EC. Individual details of the cases listed for the EC meeting & decisions taken are shown in Annexure "B" to these minutes.
