Whereas, representations/objections were received from officials through the concerned Head of Department, which have been scrutinized under rules and requisite modifications, wherever required have been incorporated in the seniority list.

Now, therefore, without prejudice to and subject to the outcome of writ petitions, if any, pending in the Courts of Law, the final seniority list of Drivers of the Excise and Commercial Taxes (Subordinate) Services depicting the position as on 01-01-2017, is hereby issued forming annexures (A-State Cadre, B-Divisional Cadre Jammu and C-Divisional Cadre Kashmir) to this Government Order.

In case any official(s) feel aggrieved with the position assigned to him, he is entitled to file a review petition, as per the relevant provisions of the Jammu and Kashmir Civil Services (Classification, Control and

Appeal) Rules, 1956. The review petitions, if any, containing facts, as have not been considered or as have come to light now and which have a material bearing on the issue of determination of seniority, should reach this office within a period of one month from the date of issuance of this order.

The date(s) of birth as well as category recorded against the officials in the Final Seniority List, shall not be taken as authentic, and, shall be subject to the verification from Service Books/Matriculation Certificates viz a viz report(s) from competent authorities.
