Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 07.02.2014 referred 07 posts of Jr. Assistant (Divisional Cadre Jammu) (OM = 5, RBA = 01 & SC = 1) of the J&K Excise and Commercial Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

**02-** Whereas, the Jammu & Kashmir Services Selection Board vide communication No. SSB/Secy/Sel/2017/11935-41 dated 20.11.2017 forwarded selection/recommendation list of 07 candidates.

**03-** Now, as recommended by the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of following 07 candidates as Junior Assistant (Divisional Cadre Jammu) in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- in the J&K Excise and Commercial Taxes (Subordinate) Service with immediate effect:

**04.** The appointment of the above said candidates shall be subject to fulfillment of the following conditions:-

A)

The appointees shall report to the **Commercial Taxes Department** within a period of 21 days from the date of issue of the order.

- B) In case of failure of said appointees to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- C) The appointees shall be allowed to join only on production of the following certificates in original:-
1. Academic/Technical Qualification Certificates.
  2. Matriculation/Date of Birth Certificate.
  3. Health Certificate issued by Chief Medical Officer.
  4. Permanent Resident Certificate issued by the Competent Authority.
  5. Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointee.
  6. Reserved Category Certificate (in case of candidates belonging to reserved category).
- D) The appointment of the candidate(s) as **Jr. Assistant** shall further be subject to the following conditions:-
- i. The appointees shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his/her appointment as **Jr. Asstt** and his/her appointment as such shall be deemed to have been cancelled ab-initio.
  - ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.
  - iii. The salary of the appointees shall not be drawn and disbursed to him/her unless the satisfactory reports in respect of (i) and (ii) above are received in his/her favour.
  - iv. The appointees shall undergo and qualify the Secretariat Assistant Training Course (Foundation Course).
  - v. The inter-se-seniority of the appointee shall be strictly as per his/her merit in the select list.
  - vi. The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-05-2009.
