Whereas, in order to fix the seniority of the the members of the Jammu and Kashmir, Excise & Taxation (Gazetted) Service, it is expedient to include the names of the officers who have been appointed substantively as ETOs/CTOs through direct recruitment/promotion.

Whereas, the tentative seniority list of the members of the Jammu and Kashmir, Excise & Taxation (Gazetted) Service, indicating the position as on 27.11.2017 was notified vide Notice, dated 29.11.2017 wherein objections, if any, were invited from all concerned within a period of 21 days from the date of the issue of the Notice;


