16- The appointment of the above said candidates shall be subject to fulfillment of the following conditions:-

- The appointees shall report to the **Commercial Taxes Department** within a period of 21 days from the date of issue of the order.
- In case of failure of said appointees to join within the stipulated period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
- The appointees shall be allowed to join only on production of the following certificates in original:-
  - Academic/Technical Qualification Certificates.
  - Matriculation/Date of Birth Certificate.
  - Health Certificate issued by Chief Medical Officer.
  - Permanent Resident Certificate issued by the Competent Authority.
  - Certificates from the District Industries Centre (DIC) and District Employment & Counseling Centre to the effect that no loan under the self-employment

category)  
D) The appointment of the candidates as Jr. Scale Stenographer shall further be subject to the following conditions:-

- i. The appointees shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his/her appointment as Jr. Scale Stenographer and his/her appointment as such shall be deemed to have been cancelled ab-initio.
- ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.
- iii. The salary of the appointees shall not be drawn and disbursed to him/her unless the satisfactory reports in respect of (i) and (ii) above are received in his/her favour.
- iv. The appointment including pay, service etc. shall be governed in terms of J&K Special Recruitment Rules, 2015 [SRO-202 dated 30-06-2015].
- v. The appointees shall be on probation for a period of 05 years.
- vi. The inter-se-seniority of the appointee shall be strictly as per his/her merit in the select list.
- vii. The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24-05-2009.


