Whereas, as per the seniority list of Inspectors of J&K Excise & Commercial Taxes (Subordinate) Service issued vide G.O No. 24-F of 2003 dated 10-02-2003 the name Mr. Hari Krishan figured at S.No.107 and his date of birth mentioned as 10-11-1947, as such he had to retire on 30-11-2005;

Whereas, on the recommendations of J&K Public Service Commission, the said officer was regularized as Commercial Taxes Officer / Excise & Taxation Officer w.e.f 14.11.2005 to 30.11.2005;

Whereas, the officer retired on superannuation from the Government service w.e.f 30.11.2005 as per the date of birth recorded in his service records i.e 10.11.1947;

Whereas, on the basis of authenticated documentary evidence i.e first/relevant pages of Service Book, Matriculation Certificate & communication dated 07-04-2006 of Deputy Commissioner, Commercial Taxes(HQ) received from Commercial Taxes Department, it transpires that the DoB of Mr. Hari Krishen Sharma was 08-10-1948 and as such, had to retire on superannuation w.e.f 31-10-2006. Accordingly the Finance Department vide Government Order No. 208-FD of 2017 dated 04.07.2017 issued orders that date of birth of Shri Hari Krishan Sharma recorded in the final seniority list issued vide Government Order No. 24-F of 2003 dated 10.02.2003 shall be read as "08.10.1948" instead of "10.11.1947.";

Whereas, the matter was again taken up with the J&K PSC/DPC for re-considering regularization of Mr. Hari Krishan, Inspector, J&K Excise & Commercial Taxes(Subordinate) Service against the available post of ETO/CTO, J&K Excise & Commercial Taxes (Gazetted) Service w.e.f "14-11-2005 to 31-10-2006" instead of "14-11-2005 to 30-11-2005".

Now, therefore, as recommended by the J&K PSC, the services of Mr. Hari Krishan, (Retd.) are regularized as Commercial Taxes Officer w.e.f "14.11.2005 to 31.10.2006" instead of "14.11.2005 to 30.11.2005".


