**Subject:- Payment of Dearness Allowance to State Government employees continuing in pre-revised Pay Scales as per 5th CPC- revised rates effective from 01.01.2018 & 01-07-2018.**

**Government Order No. 410-F of 2018  
Dated 24 - 09 - 2018**

In continuation to Government Order No. 25-F of 2018, dated 25-01-2018, it is hereby ordered that those State Government employees including Work Charged and Whole Time Contingent Paid employees, who have elected, in terms of the provisions of the J&K Civil Service (Revised) Pay Scales, 2009, to continue to draw pay in the pre-revised scales as per 5<sup>th</sup> CPC or where new scales of pay are not applicable, shall be paid Dearness Allowance as under:-

S.No.	Existing Rate of DA	Revised Rate of DA per month	W.e.f.
i.	268% of Basic Pay	274% of Basic Pay	01.01.2018
		284% of Basic Pay	01-07-2018

- a. The arrears on account of additional instalments from January, 2018 to September, 2018 shall be paid through GPF route and shall form part of the monthly salary from October, 2018 onwards.
- b. The payment of Dearness Allowance involving a fraction of 50 paise and above shall be rounded to the next higher rupee and the fraction of less than 50 paise shall be ignored.


