Sanction is hereby accorded to the release of additionality of ₹45.68 Lakh (₹ Forty Five Lakh & Sixty Eight thousand only) under State Capex Budget 2018-19 after RE in favour of District Development Commissioner, Jammu for clearing the work done liability on account of the work namely, Construction of Road from Badani Mandir to the H/o Kaku Mohalla Kalakam with culverts, Protection/retaining wall, drain and Nallah, Pyt Kote Upper, Block Bhalwal Jammu during the current financial year 2018-19.

1. The funds so released shall be utilized after the fulfillment of following conditions:-

- I. All codal formalities/procedures as required under rules shall be observed.
- II. No re-appropriation/diversion at any level and for any reason whatsoever is allowed.
- III. There shall be no overlapping of funding from any other source including languishing projects funded through JKIDFC.
- IV. The DDC shall ensure that the above mentioned works have necessary clearances/approvals/AAAs/TS of the competent authorities.
- V. DDC shall ensure the reasonability of rated.
- VI. There shall be no cost/time over run. No funds shall be utilized for meeting any cost escalation of projects/works.
- VII. There shall be no expenditure on revenue or revenue like items.
- VIII. All activities be carried out in a totally transparent manner after strict e-tendering.


