Subject: Selection list of the candidates for the post of Sub-Inspector, Finance Department (Divisional Cadre Kashmir/Jammu)- Notice for cancellation of the appointments.

Ref: Letter No. 302-II/Adm/8181/CST dated 12.02.2019, No. 302-II/Adm/8270/CST dated 21.02.2019 received from State Taxes Department & EC/Adm/144/5020 dated 06.03.2019, No. EC/Adm/144/5021 dated 06.03.2019 from Excise Commissioner.

Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 11.08.2015 referred 93 posts (OM=49, RBA=21, SC=09, ST=10, OSC=01 & ALC=03) of Sub-Inspector (Divisional Cadre Kashmir) and 74 posts (OM=21, RBA=25, SC=10, ST=12, OSC=02 & ALC=04) of Sub-Inspector (Divisional Cadre Jammu) of the J&K Excise and State Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates;

2. Whereas, the Jammu & Kashmir Services Selection Board vide No. SSB/Secy/Sel/2019/148-54 dated 08.01.2019 and SSB/Secy/Sel/2019/155-61 dated 08.01.2019 forwarded a select list of 85 and 74 candidates for the post of Sub-Inspector for Divisional Cadre Kashmir and Divisional Cadre Jammu respectively;

3. Whereas, the Finance Department vide Government Order No. 42-FD of 2019 dated 22.01.2019 issued appointment orders in favour of 90 Sub-Inspectors of Divisional Cadre Kashmir;

4. Whereas, the Finance Department vide Government Order No. 65-FD of 2019 dated 29.01.2019 issued appointment orders in favour of 56 Sub-Inspectors of Divisional Cadre Jammu;

5. Whereas, the appointees were required to report/join in the State Taxes/Excise department J&K within a period of 21 days from the date

of issuance of the orders failing which their appointment was deemed to have been cancelled without any further notice;


