

- ii. Progress report for completion of works shall be furnished by each DDC/Managing Director to Finance Department on monthly basis.
- iii. UCs/Red Account of the advance shall be furnished to the concerned quarters well in time.
- iv. The funds shall be utilized for the specific purpose/activities for which these have been released after fulfilling all codal formalities and no re-appropriation at any level shall be allowed.
- v. The funds shall neither be parked nor diverted in any case.
- vi. The funds shall be utilized after following due tendering procedure as provided under rules.


