- 4) The funds shall be utilized for the specific purpose/activities for which these have been released after fulfilling all codal formalities and no re-appropriation at any level shall be allowed.
- 5) The funds shall neither be parked nor diverted in any case.

- 7) All the work shall have AA & TS in place while releasing the payments.


