2. The Committee shall examine the eligibility of members of J&K Accounts (Gazetted) Service for confirming the following:-

- (i) Eligibility as per recruitment rules.
- (ii) Vigilance clearance.
- (iii) Assessment as per APRs as provided under rules.

The Committee shall fully examine all the cases and recommend such members of the service for placements related to stop gap arrangements who fulfill eligibility criteria fully till the matter is taken up for regularization with Public Service Commission in future/three months, whichever is earlier.

4. The Committee shall also propose placements of these officers in accordance with Transfer Policy and submit its recommendations after completely satisfying itself immediately. Any order issued in pursuance of this instruction shall not create any rights whatsoever.
