Accordingly, in case an official has got promotion In-situ under'

J&K Civil Services (HSPSS) Rules, 1996 to a pay scale higher than

which he is subsequently promoted, such an employee shall continue to dairy the higher In-situ pay scale in his personal capacity in the said Conzetted post.

#### Circular

### Bubject :- Revision of pay scales of Public Sector Undertakings.

Attention is invited to the Government order No. 92-F of 2009 dated 24-4-2009 whereunder pay scales of the employees of Public Sector Enterprises (PSE) have been revised from 1-1-2006 with effective date of implementation from 1-7-2009

- In the context, it is clarified that the State Government vide the G.O. ibid has merely provided model of pay revision and fitment benefits/pay fixation formula in regard to the revision of pay scales of employees of PSE, the implementation whereof is subject to the approval of respective Board of Directors as is the case in all policy matters involving the PSE Employees.
- Accordingly, the Managements of all the PSEs are requested to kindly place the above model of pay revision of PSEs employees before respective Board of Directors and its financial implication for consideration of the Board depending upon resources of the organization.
- It is further clarified that the provisions of SRO-93 dated 15-4-2009, vide which the pay scales of State Government employees have been revised, are applicable to persons appointed to civil services and posts in connection with the affairs of the state including those paid from contingencies or charged to works whose pay is debitable to the Consolidated Fund of the State including those on deputation to other Governments/Organizations.
- In respect of the employees of Organizations such as Autonomous Bodies, Societies etc., which are not covered under the provisions

of SR() 91/2009, the revision of pay scales would have to be carried out separately for which management of these organizations may appropriately represent to their Administrative Departments.

SRO-266.—In exercise of the powers conferred by proviso to section 124 of the Constitution of Jammu and Kashmir, the Governor is pleased to direct that in the Jammu and Kashmir Civil Services (Revised Pay) Rules, 2009, the following amendments shall be made namely:—

In the said rules, rule 8 shall be recast ab-initio as under:-

"8. Fixation of pay in the revised pay structure of employees appointed as fresh recruits on or after 1-1 2006. The following tables indicate the entry level pay in the pay band at which the pay of direct recruits to a particular post carrying a specific grade pay will be fixed on or after 1-1-2006. In such cases, where the emoluments in the pre-revised pay scale (s) (i.e. basic pay in the pre-revised pay scale (s) plus dearness pay plus-dearness allowance applicable on the date of joining) exceeds the sum of pay fixed in the revised pay, structure and the applicable dearness allowance thereon, the difference shall be allowed as personal pay to be absorbed in future increments in pay.
