In continuation of Government order No. 1155-GAD of 2007 dated 29-09-2007, sanction is hereby accorded to the extension in the contractual appointments made under the Jammu and Kashmir (Contractual Appointment) Rules, 2003 by a further period of six months w.e.f 01-04-2008 to 30-09-2008 or till the regular selections are made by the recruiting agencies, whichever is earlier. The terms and conditions of the appointees shall be the same as contained in their initial contractual appointment order.

It is further ordered that the contractual appointees shall execute a fresh contract with the appointing authorities where the previous contractual period has come to an end. In case of the contractual appointees, where the period of contract will come to an end after 31<sup>st</sup> March, 2008, the period of contract in the fresh agreement shall be restricted upto 30<sup>th</sup> September, 2008 subject to the conditions as stipulated above.
