Subject:- Grant of Special Compensatory Allowance to moving employees.

Reference:- Cabinet decision No: 109/5 dtd. 21.10.1998.

Government Order No: 1376 -GAD of 1998
D a t e d : 23. 10. 1998

In supersession of all previous orders, it is hereby ordered that:-

- (a) Moving Government employees who are provided Government accommodation both at Jammu and Srinagar shall not be entitled to any HRA.
- (b) Moving Government employees who have their own house or have made their own arrangements at Srinagar or Jammu as the case may be, should be paid HRA as per SRO 52 dated 5th February, 1998 for full year at the rates applicable for Srinagar/Jammu;
- (c) In addition to HRA as per sub para (b) above, move employees hailing from Kashmir division including Ladakh shall, subject to the conditions indicated herein below, be also entitled to the HRA at rates applicable during their posting at Jammu as also special compensatory allowance as per actual amount of rent, if they make their own arrangements at Jammu, subject to the following ceilings:-

S.No.	Category of employees	Ceiling (Rs.)
(i)	Special Secretaries and above which will include HODs, MDs and other officers of the same rank;	5000/- P.M. ✓
(ii)	Additional Secretaries including HODs, MDs and other officers of the same rank;	3,500/- P.M. ✓
(iii)	All other Gazetted officers	2,000/- P.M. ✓
(iv)	Non-gazetted employees	1,500/- P.M. ✓

1. The amount of HRA applicable for Jammu as per rates given in SRO 52 dated 5th February 1998 shall be reduced from the aforementioned ceiling.

2. The Special Compensatory Allowance shall be paid in cash after production of receipt from the land lords

The provision at sub-paras (b) and (c) of para 1 above shall apply mutatis mutandis to employees belonging to Jammu


