

Minutes of 22nd meeting of the Empowered Committee held under the Convenership of Commr/Secretary to Government, Finance Department on 24-08-2011.

Subject: Regularization of Adhoc/Contractual/Consolidated employees.

Five hundred and ninety eight (598) cases of Health Department were listed and placed before EC for consideration. The breakup of these cases is given as under:

The Empowered Committee has found 120 cases eligible out of 598 and 77 cases were found ineligible as they have not completed 7 years of service. EC also found a good number of cases (401 deficient in one or the other aspect. Cases where 7 years are not complete, it was decided that these cases shall be returned to the concerned department with the advice that they shall resubmit their cases complete in all respects as and when they complete 7 years of service. Abstract details are given in **Annexure "A"** to these minutes. In respect of deficient cases the representative of the department was advised to expedite the relevant deficient information so that further action can be taken by the EC.

Moreover, in most of the cases it was observed that some of the appointees have been employed against such post which does not exist but are presently working against another post which too is not known to have been against clear vacancies. In all these contentious cases, the concerned department shall furnish a comprehensive reply to the EC in light of relevant recruitment rules, so that a decision could be taken in the Empowered Committee while deciding these cases. Complete details of cases placed before the EC for scrutiny and verification is shown in **Annexure "B"** to these minutes.
