During discussions, Empowered Committee found that out of 12 fresh cases only 08 are found eligible and 04 cases found deficient of certain documents required under the Act. The representatives of the concerned departments were advised to expedite the deficient documents in these cases, so that EC could take a decision on them as well. Abstract details are given in **Annexure "A"** to these minutes.

As far as review cases are concerned, the deficient information/ documents have now been furnished by the concerned departments. Out of one hundred and fifty four (154) cases, one hundred and thirty one (131) have been found eligible and rest (23) deficient. In these cases concerned Administrative departments have been asked to furnish the requisite information/documents as shown against each, so that EC could decide these cases. Complete details of cases placed before the EC and decisions thereto are shown in **Annexure "B"** to these minutes.
