Jammu, the, 17th December, 2014

SRO 538 .- In exercise of the powers conferred by sub-section (2) of section 3 of the Jammu and Kashmir Entry Tax on Goods Act, 2000, (Act No. IV of 2000) and in partial modification of the notification SRO 383 dated 20th September, 2014, the Government hereby directs that the proviso attached to the said notification shall be deemed to have been substituted by the following with effect from the date of issuance of the notification dated 20th September, 2014;

Provided that the goods imported by the Telecommunication Companies into the State for immediate restoration of damaged telecommunication infrastructure should be for such places where such telecommunication equipment/infrastructure was submerged and damaged in floods and such submersion and damage is certified by the Divisional Commissioner, Kashmir;

Provided further that where Telecommunication Companies have brought into the State, the equipment/spares for restoration but have deposited entry tax during this period shall be eligible for refund/adjustment provided that the Telecommunication Companies furnish details of such equipment/infrastructure to Commissioner Commercial Taxes accompanied with a certificate from Telecom Regulatory Authority that such equipment was damaged in the floods and is replacement, not for expansion/extension of the infrastructure also with the certificate from Divisional Commissioner, Kashmir that the area where such equipment has been installed as replacement was submerged in the water;

The exemption shall be deemed to have been extended upto 31st October, 2014.


