Subject: Clarification to Rule 26(b) of the Jammu and Kashmir Civil Services (Leave) Rules, 1979.

Doubts have been expressed from various quarters as to whether the provision of para VII(B) under Rule 26(b) of the Jammu and Kashmir Civil Services (Leave) Rules, 1979 inserted vide SRO 230 dated 26-07-1991 is applicable after the introduction of SRO-124 dated 17-04-1998.

2. The issue has been examined in the Finance Department and it is clarified that the special dispensation regarding credit of 15 days Earned Leave and the procedure to regulate the same continues to remain in force subsequent to enhancing the ceiling of Earned Leave from 240 days to 300 days in terms of SRO-124 dated 17.04.1998. In cases where the earned leave at credit as on 1<sup>st</sup> January/1<sup>st</sup> July is 300 days or less but more than 285 days, credit of earned leave for 15 days shall be kept, separately and first adjusted against any earned leave that the Government servant may avail during the ensuing half-year and the balance, if any, credited to the earned leave account at the close of the half-year subject to the maximum ceiling of 300 days. If the Earned Leave taken during the half-year is more than 15 days, the amount in excess of 15 days shall be debited to the leave account.
