Subject:- Stepping-up of Pay of Mr. Dharamveer Gupta, Assistant Accounts Officer (Retired).

Government Order No. 209-F of 2012,

Dated: 14 -09-2012.

Whereas, the Chief Accounts Officer, Relief Organization (M), Jammu vide his letter No. CAOROJ/Acctt/1118 dated 01.02.2010 had forwarded pay anomaly case of Mr. Dharamveer Gupta, Assistant Accounts Officer, retired from Government service on superannuation on 28.02.2009, for accord of sanction to the stepping up of pay of the official;

Whereas, on examination of the case it was revealed that the above mentioned Assistant Accounts Officer had represented for stepping up of his pay from ₹ 9475/- in the pay scale of ₹ 7450-11500 (Pre-revised) to ₹ 9925/- in the pay scale of ₹ 8000-12950 (Pre-revised) to bring his pay on par with his junior counterpart, namely, Mr. Kulbushan Singh, Assistant Accounts Officer;

Whereas, the case was processed and submitted to the Administrative Department for concurrence of the Competent Authority viz. Financial Advisor and Chief Accounts Officer, Finance Department;

Whereas, the Financial Advisor/Chief Accounts Officer, Finance Department vide his U.O. No. FD/N/Step-up/2010-12 dated 25.02.2011 conveyed his concurrence to the stepping up of pay, among others, in favour of the aforementioned Assistant Accounts Officer notionally w.e.f. 01.08.2008 and monetarily from the date of issue of the sanction;

Whereas, vide Government Order No. 59-F of 2011 dated 08.03.2011, sanction was accordingly accorded to the stepping up of pay of the Assistant Accounts Officer from ₹ 9475/- in the pay scale of ₹ 7450-11500 (Pre-revised) to ₹ 9925/- in the pay scale ₹ 8000-12950 (Pre-revised) notionally w.e.f 01.08.2008 and monetarily from the date of issue of sanction;

Whereas, Mr. Dharamveer Gupta, Assistant Accounts Officer, retired from Government service on superannuation on 28.02.2009, has represented through Chief Accounts Officer, Relief Commissioner (M), vide No. RCM/Acctt/2060 dated 30.03.2012 stating therein that sanction issued in his favour for stepping up of his pay did not entitle him to any monetary benefit as he had retired from Government service on 28.02.2009 i.e. prior to the date of issue of the sanction;

Whereas, the case was again processed and submitted to the Administrative Department for re-examination in light of contents of the representation dated 30.03.2012 of the retired Assistant Accounts Officer; and

Whereas, after review of his case, the Financial Advisor/Chief Accounts Officer, Finance Department vide his U.O. No. FD/N/SUC/2011-06-45 dated 31.07.2012 conveyed as under:-

"Finance Department accords sanction for stepping up of pay in favour of Mr. Dharamveer Gupta, retired Assistant Accounts Officer monetarily one month prior to his date of retirement i.e., w.e.f. 01.02.2009. It is to record here that previously stepping up of pay in favour of the above mentioned official was granted notionally w.e.f. 01.08.2008 and monetarily from the date of issuance of sanction as conveyed vide U.O. No. FD/N/stepup/2010-13 dated 25.02.2011. The present sanction is in supersession of the sanction conveyed vide above referred U.O. No. to the extent of monetary benefit only".

Now, therefore, in partial modification of Government Order No.59-F of 2011 dated 08.03.2011, sanction is hereby accorded to the stepping up of pay in favour of **Mr. Dharamveer Gupta, retired AAO from ₹ 9475/- in the PR scale of ₹ 7450-11500 to ₹ 9925/- in the PR scale of ₹ 8000-12950 notionally w.e.f. 01.08.2008 and monetarily from 01.02.2009 i.e, one month prior to the date of his retirement.**


