Empowered Committee discussed twelve (11) fresh cases and also reviewed two hundred and seventy one(271) deficient cases of different departments. The department-wise breakup of these cases is given as under:

Empowered Committee found that out of 11 fresh cases only 09 are found eligible and 02 cases have been found deficient on account of documents required under the Act. The representatives of the concerned departments were advised to expedite the deficient documents in these cases so that EC could take a decision on these cases as well. Abstract details are given in **Annexure "A"** to these minutes.

As far as review cases are concerned, the deficient information/ documents have now been furnished by the concerned departments. Out of two hundred and seventy one (271) cases, one hundred and fifty (150) have been found eligible and rest (121) deficient. In these cases concerned Administrative departments have been asked to furnish the requisite information/documents as shown against each, so that EC could decide these cases.

The cases of Revenue Departments, Tourism Department and Forest departments were also placed before the EC for review. Regarding the case of Revenue department, it was decided that since the incumbents have not completed 7 years of compulsory period, as such are not eligible for regularization at this juncture. As and when these two contractual employees complete 7 years of service, department shall revert back with complete documents as required under the Act for consideration of EC.

In case of Sh. Azad Yaseen, presently working as ATO in Tourism Department, it was decided that since the incumbent has initially been appointed against the post of Junior Agriculture Assistant, as such has been considered against the post of Junior Agriculture Asstt. in Agriculture department and not in Tourism Department.

In regard to the case of Rabia Shah, Law Officer Forest Department, it was decided that since the case of the incumbent has not been furnished to the EC within the prescribed period of time viz 31.1.2011, as such could not be entertained for consideration by the EC. Complete details of cases placed before the EC and decisions thereto are shown in Annexure "B" to these minutes.
