Out of one hundred & twenty two (122) review cases, the Empowered Committee found forty nine (49) cases eligible and seventy three (73) cases were again found deficient on account of certain information/ clarification from the concerned departments. Regarding two fresh cases, one has been found eligible and one deficient. The representatives of the concerned departments who were present in the meeting were advised to expedite the requisite deficient documents in these cases so that Empowered Committee could decide these cases as well. Abstract details are given in **Annexure** "A" to these minutes.

During discussion, the Empowered Committee also decided that in respect of those Adhoc/Contractual/Consolidated cases wherein the concerned departments have not furnished the complete information/documents as required under the provisions of the Act, need not be placed before the Empowered Committee for scrutiny in absence of requisite documents. Thus, the concerned departments have been advised to furnish the deficient information/documents in such cases complete in all respects, so that EC could decide these cases as well.
