Out of Eighty one (81) cases, the Empowered Committee found Sixty (60) cases eligible and 21 cases were found deficient on account of certain information/ clarification from the concerned departments. The representatives of the concerned departments who were present in the meeting were advised to expedite the requisite deficient documents in these cases so that Empowered Committee could decide these cases as well. Abstract details are given in **Annexure "A"** to these minutes.

While scrutinizing the cases of Social Welfare Department, it was decided that since the Empowered Committee has already cleared the cases of adhoc/contractual/consolidated employees of Social Welfare Department in earlier meetings who were working in the ICDS Project, and on the same analogy, these cases could be considered for regularization. Moreover, in the case of PHE/I&FC Department, it was decided that since the incumbent Sh. Verinder Singh, initially engaged against the non-existent post of Computer Operator, had been drawing his salary against the post of Jr. Assistant, as such the decision taken by the Empowered Committee in its 17th ECM shall be deemed to have been annuled. Thus, while re-considering the case of Sh. Verinder Singh, the Committee resolved that his services shall be regularized against the post of Jr. Assistant.
