During the scrutiny, out of the one hundred & one (101) fresh cases, the Empowered Committee found ninety one (91) cases eligible and ten (10) cases deficient on account of certain information/ clarification from the concerned departments. The representatives of the concerned departments who were present in the meeting were advised to expedite the deficient documents in these cases so that EC could decide these cases as well. Abstract details are given in **Annexure "A"** to these minutes.

As regards the review cases, some of the departments were found to have furnished the deficient information/ documents and as such twenty (27) cases were found eligible. However, 11 cases were again found deficient and three (3) cases of Agriculture Production Department were found ineligible. In regard to deficient cases concerned Administrative departments were asked to furnish the requisite information/documents as shown against each. Complete details of cases placed before EC and decisions taken thereon are shown in **Annexure "B"** to these minutes.
