Whereas, the J&K Services Selection Board vide communication No. SSB/Secy/Sel/2015/16481-87 dated 21-12-2015 forwarded Selection list of the 41 candidates for the post of Junior Assistant(Divisional Cadre Kashmir) and 46 candidates for the post of Junior Assistant (Divisional Cadre Jammu) advertised vide Advertisement Notice No.06 of 2013 dated 10-5-2013 No. SSB/Secy/Sel/2015/18028-34 dated 31-12-2015 forwarded the Selection list of the 16 candidates for th post of Juniors Assistants(Divisonal Cadre Jammu) and 17 candidates for the post of Junior Assistants(Divisional Cadre Kashmir) advertised vide Advertisement Notice No. 02 of 2011 & 02 of 2013 dated 16-02-2013; and

Whereas, the formal appointment orders were issued by Finance Department vide Government Order No. 17-F of 2016 dated 19-01-2016, Government Order No. 60-F of 2016 dated 01-03-2016, Government Order No. 150-F of 2016 dated 20-06-2016, No. 151-F of 2016 dated 20-06-2016 & No. 152-F of 2016 dated 20-06-2016, in respect of the selected candidates with the directions to report to Commercial Taxes/Excise Departments as the case may be; and

3. Whereas, pursuant to Government Order No. 150-F of 2016 dated 20-06-2016, No. 151-F of 2016 dated 20-06-2016 & No.


6. Whereas; the department inadvertently issued notice in respect of some candidates/appointees under endorsement No. ET/Estt/03/2016 dated 21-11-2016.

Now therefore, in supersession of notice issued under endorsement No. ET/Estt/03/2016 dated 21-11-2016, the following 15 appointee(s), who have not reported for joining in the Commercial Taxes in pursuance of Government Order No. 150-F of 2016 dated 20-06-2016 , No. 151-F of 2016 dated 20-06-2016 & No. 152-F of 2016 dated 20-06-2016 are hereby once again directed to report in Commercial Taxes, alongwith reasonable justifications for cause of delay, within a period of 10 days from the date of issuance of this notice, failing which their appointment as Junior Assistants(Divisional Cadre Kashmir/Jammu) of the J&K Excise & Commercial Taxes (Subordinate) Service in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- shall be deemed to have been cancelled ab-initio:-
