**Subject:** Clarification regarding Payment of 7<sup>th</sup> Pay commission arrears in respect of Government servants who may quit the service by Resignation.

Clarification has been sought by various quarters regarding payment of 7<sup>th</sup> pay commission arrears in respect of such government servants who have resigned from government service. The matter has been examined in Finance department and it is clarified that:

- a) In case of persons who have resigned from government service between 01-01-2016 and 31-03-2018 , their 7<sup>th</sup> pay commission arrear dues will be paid in cash as per the road map notified vide Govt. order No.223-F of 2018 dated 24-04-2018 in three half yearly installments.
- b) Further, in case an employee resigns from a post to take up another appointment in state government his due arrears in respect of previous appointment shall also be credited to GPF account only.
