
**Subject: Furnishing of details of the projects which are unfunded/languishing over the years.**

In terms of Government Order No. 281-PD of 2018, dated: 08-09-2018, High Powered Committee (HPC) has been constituted for approving unfunded projects which shall be funded through Jammu and Kashmir Infrastructure Development Finance Corporation (JKIDFC) Ltd.

4. The Deputy Commissioner Leh and Deputy Commissioner Kargil may send the list of projects in the prescribed performa by 25<sup>th</sup> September, 2018 so that projects pertaining to Ladakh are cleared in first meeting of HPC in view of limited working season left there.
