Subject: Clarification on regulation of pay of an employee on his/her encadrement.

Clarification is being sought by various quarters regarding regulation of pay of an employee on his/her encadrement to a post in other service.

The issue has been examined in Finance Department and it is clarified that encadrement to a post has the notion of fresh appointment to that post, not as promotion with the exception that service, pay and pensionary benefits earned in the past appointment are protected and counted with future service. Therefore, the pay of an appointee on encadrement in an equivalent or higher post shall be fixed under Article 77D-(I) (a) of J & K CSR, Volume-I read with provisions of relevant pay revision rules as applicable to fresh appointees.

However, the re-fixation of pay, if any required, shall be carried out notionally up to 31-07-2018 without payment of any arrears.
