Subject:- Schematization of Capex Budget 2019-20 and authorization Of funds thereof.

Circular: 10 -FD of 2019 Dated: 27 -03-2019

Attention of all Administrative Departments is invited to para (i) below Section 4 of the Jammu and Kashmir Appropriation Act (No 2), 2018 which necessitates that:

"Finance Department shall release both Revenue and Capital budget to all the Administrative Departments within one month of the passage of the Appropriation Act."

2. Further in terms of para (iii) & (v) below Section 4 of the Jammu and Kashmir Appropriation Act, 2018 necessitates that:

"The Finance Department shall ensure that all capital allocations to be made in the next fiscal bear proper classifications, indicating therein the "Name of the work/Scheme" against Detailed head-115 Works as laid out in the authorized allocations. In the absence of the above schematic classification, the relevant Capex release shall be deemed as invalid and not open to being operationalised.

The Finance Department shall mandatorily upload departmentwise "Name of the Schemes/Works/Projects" forming part of the Capex for the fiscal 2019-20, or, as per the format notified from time to time along with the respective allocations on its website."

3. It has come into notice of the Finance Department that despite clear rule position, none of the Administrative Department has furnished the information resulting to delay in schematization of Capex Budget for the fiscal 2019-20 and authorization thereof.

4. Accordingly, all the Administrative Secretaries are requested to kindly furnish the following information by tomorrow positively through special messenger (hard and soft copy) so that the Finance Department may be able to schematize Capex Budget of 2019-20 and authorize funds well before the commencement of next financial year.
