Each Department is supposed to clear the electricity bills of their offices raised by Power Development Department every month by way of contra-credit/book adjustment at respective Treasuries.

To streamline payment of electricity dues, it is impressed upon all the Administrative Secretaries to instruct the Heads of the Department (s) and Drawing and Disbursing Officer(s) under their administrative control to clear the Electricity dues immediately. The properly assessed bills shall be cleared by each department on monthly basis and shortfall in budget allocation with proper justification shall be projected in the Revised Estimates 2021-22.
