Subject:-Regulation of payment of wages to Daily Rated Workers and Casual Labourers.

CIRCULAR

Attention of all Administrative Departments is drawn towards Government Order No. 121-F of 2022 dated 23.04.2022, whereunder, wages of duly engaged Daily Wage earners, including Casual Labourers, have been revised to Rs. 300/- (Rupees Three Hundred only) per day w.e.f 1st of April, 2022.

The payment of wages in favour of the Daily Rated Workers, including Casual Labourers shall be regulated as under:

- a) Payment of wages in favour of Daily Rated Workers/Casual Labourers, whose Aadhar based Bio-metric authentication has been reported to the Finance Department, shall be made as per the rates notified by the Finance Department, taking into account number of hours.
- b) The Bio-metric attendance for all Daily Rated Workers/Casual Workers is mandatory. It shall be for two times a day, indicating duration of work.
- c) The Bio-metric Attendance shall not be used for claiming Government Jobs, but shall be only for the limited purpose of payment of wages to the Daily rated workers/Casual Labourers.
- d) Person(s) working for short duration shall not be paid for full day.
- e) The Departments shall report the cases where instructions of Finance Department are violated.
- f) The engagement of Daily Rated Workers/Casual Labourers shall be restricted to budget available and no liability shall be created.
