In continuation to the Government Order No. 98-F of 2022, dated 31.03.2022, O.M No.FD-BDGT0GEN/27/2021-03-FINANCE DEPARTMENT dated: 22.09.2022 and OM of even No. dated: 07.11.2022, Finance Department conveys authorization to the release of further funds through BEAMS under Revenue Component for the financial year 2022-23 to the extent as shown below or as per revised projections, whichever is less:

- 25% under all remaining "Detailed Heads" (20% under detailed head: 002-Travelling Expenses) except the below mentioned detailed heads which shall be released on case to case basis:

003-LTC;  
046-Purchase of vehicle;  
054-Furniture and Furnishings;  
104-Land compensation;  
201-Interest;  
216-Purchase of Power;  
311-cost price of Food Grains;  
449-Snow Clearance;  
799-Suspense Debit;  
1076-Disaster Response Fund.

However, the revenue budget so authorized shall be subject to the following conditions:

1. The Departments shall review the expenditure of the subordinate offices/DDOs and shall ensure that further funds are released wherever the expenditure level is at least 75% against the 50% funds already released during April, 2022.
