out of District Capex 2022-23.**

In continuation to above referred Government Order and subsequent authorization of funds from time to time, Finance Department conveys authorization to the release of further funds to the extent of 25% through BEAMS aggregating to 100% in respect of **DDC, BDC and PRI Grants** out of approved BE 2022-23 or as per revised figures under RE 2022-23, whichever is less, in respect of all the works/activities under DDC, BDC and PRI Grants of District Capex.

Besides, Finance Department also conveys relaxation to the expenditure restriction of 15% during the month of March, 2023 & 30% during the last quarter of current FY 2022-23 for works executed within these grants.

However, the utilization of funds shall, however, be subject to other conditions as stipulated vide Government Order No.100-F of 2022 dated: 31.03.2022.
