Whereas the final seniority list of Junior Scale Stenographers of the J&K Excise and Commercial Taxes (Subordinate) Service was last notified vide Government Order No. 284-F of 1998 dated 22.10.1998 as it stood on 1.3.1998;

Whereas, in the year 2012, the Finance Department issued a circular vide No. ET/Estt/25/2012 dated 15.05.2012, whereunder a common tentative seniority list was drawn up and the officials were asked to convey their objections, if any, to the position assigned to them in the said tentative seniority list within a period of 21 days from the date of the issuance of the circular;

Whereas, after the issuance of the above circular, it was found that the Jammu and Kashmir Civil Services (De-centralization & Recruitment) Act, 2010 and the rules made thereunder provide for maintenance of separate seniority list for each district, division and state cadre for all categories of posts included in the respective cadres;

Whereas, the tentative common seniority list of Junior Scale Stenographers issued vide circular No. ET/Estt/25/2012 dated 15.05.2012 was found to be in contravention with the provisions of the Jammu and Kashmir Civil Services (De-centralization & Recruitment) Act, 2010 and the rules made there under;

Whereas, a separate tentative seniority list of Junior Scale Stenographers (State/Divisional Cadre) was drawn up strictly as per the merit obtained by the officials in their respective select list issued

by the SSRB from time to time as also in accordance with the Jammu & Kashmir Civil Services (De-centralization & Recruitment) Act, 2010 and the rules made there under;

Whereas, the seniority list so drawn up takes into account the retirements, deaths and appointments made against the posts of Junior Scale Stenographers from time to time on substantive basis after 01.03.1998;

Whereas, vide Government Order No. 247-F of 2013 dated 17-12-2013, the revised tentative seniority list of Junior Scale Stenographers(Cadre-wise) forming **Annexure-A** (State Cadre), **Annexure-B** (Divisional Cadre Kashmir) & **Annexure-C** (Divisional Cadre Jammu) to the said order, as it stood on 01.01.2012 was notified and fresh objections, if any, were called from the concerned within a period of 15 days from the date of issuance of this order through their respective Heads of Department (HODs).

Whereas, Commissioner Commercial Taxes vide communication No. 194-Adm/2675/CCT dated 21-02-2014 informed that only incumbent namely Mr. Sayed Arshad Ahmad, Jr. Scale Stenographer, Divisional Cadre Kashmir, figuring at S.No. 10 of **Annexure-B** of Government Order No. 247-F of 2013 dated 17-12-2013, is aggrieved with his position as per merit list of SSB followed by initial appointment order No. 94/Adm of 1994 dated 27-08-1994. The claim of the incumbent has been examined and found correct as per documentary evidence and as such his position has been refixed accordingly.

Now, therefore, final seniority list of Junior Scale Stenographers(Cadre-wise) forming **Annexure-A** (State Cadre), **Annexure-B** (Divisional Cadre Kashmir) & **Annexure-C** (Divisional Cadre Jammu) to this order as it stood on 01.01.2012 is notified.
