Whereas, the Finance Department vide communication No. ET/Estt/154/2012 dated 26-03-2013 referred 07 posts of Junior Assistant (State Cadre) of the J&K Excise & Commercial Taxes (Subordinate) Service to J&K Services Selection Board for selection of suitable candidates; and

- 2- Whereas, the J&K Services Selection Board vide communication SSB/Secy/Sel/2017/1002-09 dated 21-01-2017 has forwarded the selection list of the 06 candidates for the post of Junior Assistant (State Cadre) advertised vide Advertisement Notice No. 06 of 2013; and
- 3- Whereas, the Board, has also intimated that out of total 07 advertised posts (State Cadre) one post under SC category have been kept un-filled due to non-availability of eligible candidate; and
- 4- Whereas, the select list inter-alia includes the following 02 candidates (State Cadre) in whose case the Board has withheld its recommendations:-

- Whereas, in the above backdrop, the department has to consider formal appointment in favour of the only 04 selected candidates (State Cadre) (excluding 02 candidates at S.No. 01 & 02 under OM category) of the select list whose recommendations have been withheld by the Board; and
 - Now, therefore, as recommended by the J&K Services Selection Board, sanction is hereby accorded to the temporary appointment in favour of 04 selected candidates (State Cadre) indicated in "Annexure-A" to the order as Junior Assistant (State Cadre) in the Pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- in the J&K Excise and Commercial Taxes (Subordinate) Service with immediate effect subject to fulfillment of following conditions:-
 - The appointee(s) shall report to the respective A) departments as indicated against each in "Annexure-A" to this order within a period of 21 days from the date of issue of the order.
 - In case of failure of any appointee to join within the B) stipulated period, his/her appointment shall be deemed to have been cancelled without any further notice.
 - The appointee(s) shall be allowed to join only on C) production of the following certificates in original:-
 - Academic/Technical Qualification Certificates.

Matriculation/Date of Birth Certificate.

3. Health Certificate issued by Chief Medical Officer.

Permanent Resident Certificate issued by the Competent Authority.

Certificates from the District Industries Centre(DIC) and District Employment & Counseling Centre to the effect that no loan under the self employment scheme has been taken by the appointee.

Relevant category certificates (in case of candidates belonging to reserved

categories).

- D) The appointment of the candidates as Junior Assistant (State Cadre) shall further be subject to the following conditions:-
 - Each appointee shall give an undertaking duly attested by the First Class Magistrate in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from Inspector General of Police, (CID), J&K to whom a reference shall be made by the concerned HoD, the candidate shall have no right to claim his/her appointment as Junior Assistant and his/her appointment as such shall be deemed to have been cancelled ab-initio.
 - ii. If on verification, the certificate(s) produced by the appointees are proved to be fake or forged, the appointment shall be cancelled ab-initio.

- iii. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
- iv. The appointment of the said candidates shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated 24.12-2009.
- v. The appointee(s) shall be on probation for a period of 02 years and shall undergo and qualify the Secretariat Assistants Examination Course (Foundation Course).
- vi. The inter-se-seniority of the appointee(s) shall be strictly as per their merit in the select list.
